The 11th Wing requests proposals from qualified financial institutions to provide ATM services on Joint Base Anacostia-Bolling (JBAB). This RFP is for an ATM-only solution, envisioning up to five strategically placed ATMs to meet the needs of our community following the closure of the Pentagon Federal Credit Union branch on April 19, 2024. The Department of the Air Force Comptroller will evaluate proposals, and compliance with DoD FMR, Volume 12, Chapter 33, and DoD Instruction 1000.11 is mandatory. For your reference:
